The four cornerstones of TICTAC are Duties & Rights, Connectivity, Convergence and Collaboration for and of, the tribal citizens of India.

The primary objective of TICTAC is to indulge in 'Thought Leadership' and 'Policy Advocacy' at National & International levels.

TICTAC is a body that works for those who work for indigenous people. It is acutely aware of the fine line dividing a Chamber of Commerce & a grassroots Non-Governmental Organisation.

TICTAC strictly works only as a facilitator and network platform to bring together those that are experts at onground execution.

TICTAC can be seen as the facilitator, which ensures that all such stakeholders who are, or have anything to do with tribal affairs should find a common positive platform; thus assisting the government to revisit policy where necessary and continue to raise the very definition of the indigenous people and the decisions affecting their welfare.

TICTAC endeavours to shift the centre of gravity from tribal welfare to tribal ownership through Thought Leadership.

TICTAC is committed to revisit the traditional positioning of Tribals as 'Aadivasis' and bring them into the far more dignified positioning of 'Aadi-Bharatiya'.

- 1. TICTAC is building the much needed connectivity, convergence & collaboration platform for the benefit of the Aadi-Bharatiya (Tribal) population of India
- 2. TICTAC has been set-up to work as a structured non-governmental organisation that will connect with Indian & global tribal groups to bring their best practices into one common knowledge platform.
- 3. Through TICTAC, the government will have easy access to an organised chamber, for meaningful policy advocacy, big-data banking, knowledge consolidation, focused participation and structured interface whenever it wants to communicate with various tribal interest groups as well as the entire Aadi-Bharatiya eco-system.
- 4. TICTAC also collaborates with other specialised chambers of commerce that enjoy deep penetration into India's Agriculture, Industry & Commerce sectors whenever such chambers need to deal with tribal affairs.

Roadmap 2030

- Invite Membership Build a consortium of various stakeholders including Tribal individuals, Tribal groups, Tribal representatives, corporates, non-profit organisations and SMEs that are directly or indirectly working for the economic development of tribal groups in different parts of India
- Organise events conferences/ seminars, workshops, FGDs, lectures, exhibitions, festivals, haats/ marts and webinars to benefit tribal communities of India
- Encourage advocacy and move policy advisories to the government at state and central levels on behalf of the tribal community
- Create a common platform for tangible action research and collate primary data for agriculture, education, civil & human rights issues. Move towards Big-Data assimilation of Tribal India.
- Facilitate training programs and skill development through experts of the specific sectors
- Partner to bridge the gap, wherever existent, between availability of central and state financial schemes and micro-finance opportunities for tribal development and its meaningful utilisation
- Aggregate various Self Help Groups, Producer companies and Co-operative societies working for tribal welfare on a common platform of TICTAC for promoting trade, agriculture and commerce that would benefit Tribals
- Develop meaningful partnerships and synergies between TRIs, Eklavya Vidyalayas, State & Central Departments, New initiatives and existing success leaders
- Promote indigenous sports among tribal populations and bring such sports into the mainstream of Khelo India
- Promote the leveraging of Geographical Indicators (GI) where appropriate and hand over charge to Tribal Groups, cooperatives or consortiums
- Develop a Tribal Labour Market Information System (TLMIS) and connect it to the national labour exchange.
- Connect with other tribal/indigenous chambers of commerce as well as those of similar interests in India and in other countries
- Raise funds nationally and internationally to support innovative projects aimed towards socio-economic development of tribal India
